# Busker Rules & Regulations

## For the 4<sup>th</sup> Street Lilac Festival

### Sunday May 31, 2009

1. Buskers are considered performance artists which would include musicians, jugglers, magicians, poets, balloon artists and actors. Face painters, crafts people, psychics, tarot card readers and painters **do not** fit into this category and would be considered a vendor at the event. Vendor registration can be found on our website at [www.lilacfestival.net](http://www.lilacfestival.net) (click on Lilac Festival and then Registration).
2. Payment must be made in person in order to be given a valid 2009 4th Street Lilac Festival busking permit.
3. Only registered buskers are authorized to perform at the 4th Street Lilac Festival. A valid permit must be displayed during ALL performances.
4. This is a family event and immediate removal will be enforced if there is any inappropriate behavior such as the use of profanity, intoxication, intimidation, offensive/lewd conduct or unsuitable attire. Physical or verbal abuse to **anyone** at the 4th Street Lilac Festival is not permitted. Removal from the event site can be enforced by event organizers, site managers, security or The Calgary City Police. This could also result in a permanent performance suspension from the 4th Street Lilac Festival.
5. Under no circumstances can fire or dangerous props be used as part of an act.
6. Buskers are not allowed to sell merchandise unless a "retail permit" was purchased and the applicable permit was provided by the 4th Street Lilac Festival. Items being sold can only be the work of the registered performer(s) or group and can only be offered for sale during performance. Sale of merchandise **must not** be done in an aggressive manner.
7. Interfering with programmed entertainment on any of the 4th Street Lilac Festival stages **WILL NOT BE TOLERATED** and you will be asked to leave the event site. This can be enforced by security, event organizers, site managers, stage managers and The Calgary City Police.
8. Buskers are not to obstruct street vendors, designated sponsor sites, children's area, any emergency facilities and non-barricaded streets.
9. No sound system, public address or amplification that would require any electrical service is permitted.
10. All performers must have a tidy, clean appearance and conduct themselves in a cooperative, professional manner.
11. If under the age of 16 a parent or guardian's consent is required (please see bottom of registration form). Parental supervision is also required the day of the event.

12. No smoking, alcoholic beverages or drugs are permitted on the event site.
13. Buskers may receive donations for their performances. Aggressive solicitation for receipt of donations is not tolerated. Donations regardless of the amount must be accepted without comment.
14. Only small (2x2 feet maximum) signs, banners or displays related to the performer are acceptable. The 4th Street Lilac Festival reserves the right to remove these signs if they interfere with vendors, business activity, event related programs, pedestrian or vehicle traffic, or if it obstructs views or any other signs.
15. Performers must not in any way act as representatives/employees of the 4th Street Lilac Festival.
16. Use of Central Memorial Park is allowed. Please show respect for all memorials located in the park, failure to do so will result in immediate removal from the event and exclusion from any future 4<sup>th</sup> Street Lilac Festivals.
17. All rules and regulations are enforceable by the 4th Street Lilac Festival organizers, site managers, security, stage managers and The Calgary City Police. If broken performers will be asked to leave the event site immediately.
